



Dear Parents and Carers,

We are delighted to announce that our plans to reopen have now been authorised by the KHDA and quality assured by GEMS. Our full Return to School plans, guidance can be found on website: https://www.gemsfoundersschool-mizhar.com/for-parents/reopening-plan-2020-2021/

We are really excited to have the children back and we have worked throughout the summer to have everything ready. The school has prioritised the children's safety at every turn and with every decision and we have created a safe and protected space which will allow the children to start a phased return.

These plans and measures are in place to reduce risk and keep all safe. We are aiming to create a hygienically clean and protective space which allows our children to grow, to learn and to flourish happily and safely. To do this, we will need everyone helping us to follow some rules. Some key headlines:

Learning Options:

- Face—to-face teaching in school prioritised for FS1, FS2 and Yr 1. Socially distanced and "bubble based" at reduced timings and in two shifts
- Face—to-face blended teaching in school every day for Yr 10 (socially distanced)
- Face-to-face teaching on alternate days for Yr 2-9 in conjunction with distance learning
- Distance learning only option for those with medical conditions or those who choose it

Travel and Entrance:

- No Bus service during first week (30th Aug – 3rd Sept)
- Bus running at 50% capacity (with social distancing)
- Temperature checks upon entry to designated areas
- No parents allowed into school site or near learning areas/ classrooms
- Designated pick and drop off entrances and exits.

Teaching:

- In allocated groups and class bubbles
- Social distancing in classes using single tables and where appropriate screens/ dividers
- PE noncontact sports only
- Exams / assessments will go ahead
- No ECAs

Hygiene:

- Round the clock cleaning and sanitising.
- Extensive hand sanitisers and PPE
- Students will eat in designated areas and be supervised and supported to stay safe.
- Students above 6 years of age need to wear face masks.

We cannot wait to see you all again in the new academic year and welcome you all back to school



It is important you understand and adhere to the following measures detailed below

Curriculum Delivery:

For face-to-face learning in the physical building, students will be required to bring their device to school as to reduce the reliance on any paper-based materials.

As to ensure siblings are able to attend school on the same days in the rotational models (Year 2-10), student groups will be based on houses:

- Ambitious Archers & Courageous Knights in one rotation
- Resilient Riders & Respectful Royals in the alternating rotation

Distance Learning:

- 100% Distance Learning approach will be provided in case of the following:
 - Students who have been advised to be quarantined at home
 - Students in the high-risk category
 - Students who are feeling unwell and are unable to attend school
 - Family members exhibiting symptoms and the parents wish to keep their wards at home
 - Parents who do not feel comfortable to send their children to school



Face-to-face:

	Students will have a designated chair and table with no swapping allowed Group activities such as school trips and celebrations are suspended. Students must bring their own exclusive stationary items, devices or gadgets (i.e. laptops, tablets, headphones, etc.). Student cannot share their stationery. Any extra-curricular activities will be offered digitally. PE lessons will adhere to physical distancing. Children who participate in PE are not requires to wear face masks. PE lessons will focus on sports that do not require physical interaction

Stay a	t home if unwell:
	GFM will be enforcing a strict policy of "staying at home if unwell". If your child is unwell please do not send them to school.
Entry,	Pick up, and GFM Premises access:
	GFM will be fitted with a number of thermal imaging cameras, which will be located at specific entrance points into the school. These will monitor the temperature all children, staff and visitors to the school site
	Anyone with a detected temperature ≥37.5 °C will not be allowed entry to the school site. All children using bus transportation will have their temperature checked upon entry. Anyone with a detected temperature ≥37.5°C will not be allowed entry.
	Teachers and students older than 6 years of age (Year 2 and above) are required to wear
	face masks at all times. Only one family member is allowed to enter at set designated areas (not inside the school
	building which are near classrooms) for drop off/pick up his/her child.
	People with compromised medical conditions, including the elderly, should not come for
	drop off and pick up.
	The school will implement a staggered entry and exit procedure to eliminate overcrowding and to maintain 2 metres physical distancing in high traffic areas.
	It is extremely important below are adhered to as to avoid congestion during pick-up and drop-off

□ Family members have a maximum time limit of 10 minutes in the designated area to pick up / drop off with no crowding, maintenance of a 2 metres distancing, and wearing of masks at all times.

Meetings:

□ Whenever possible, meetings with parents will take place remotely using MS Teams. For urgent or critical cases that require a meeting at the school site, this will be reviewed and approved by the Principal via an approved appointment. Appointments can be requested by calling the school or contacting out PRE at pre-gfm@gemsedu.com

Screening & Symptomatic cases:

- If a child/teacher/staff shows any symptoms of COVID-19 while at school, they will be isolated instantly, and you will be notified immediately.
- The patient cannot return to school until the PCR result is obtained. If the result is negative
 and there is a clinical assessment of a probable COVID-19 case, the patient should
 complete a 14-day quarantine. If the result is negative and there is no clinical assessment
 for a probable case, the child/staff/teacher can resume schooling so long as they are
 symptom-free.



 If the result is positive, the traced contacts of the patient will need to undergo a 14-day quarantine

Hygiene:

GFM will have a strict hygiene, cleaning and sterilization programme in place.
Children will be supported in developing a hand washing regime with allocated hand
washing breaks.
Younger children will be assisted with handwashing.
Hand sanitizers will be distributed across the school premises.
Anyone entering the premises will need to be checked for wearing a mask and will be
asked to use the hand sanitizer available at the entrance.
Contactless / online payments are encouraged.

We will be publishing videos and webinars in the comings weeks so you are fully informed of every aspect of how we will operate. Our focus at the beginning of the year will be very much on the successful reintegration of students back into school life where they feel happy, safe and comfortable retuning.
